1. Adopter will provide proper and sufficient food, water, shelter and kind and caring treatment for the animal at all times. _____
2. Adopter will take the animal to a veterinarian for regular examinations and immunizations and will seek immediate veterinary care should the animal become ill or injured, at the adopter's expense. _____
3. Adopter is fully aware that P.A.W.S. makes no guarantees whatsoever as to the health, temperament, mental disposition, and training of the animal. In adopting the above-described animal the adopter does so with the understanding that it is a stray or unwanted animal and as such, may have been exposed to a variety of diseases and parasites, even though the animal has seen a veterinarian. _____

4. Adopter here by fully and completely releases P.A.W.S, its agents, servants, volunteers, employees, and community partners from any defects or illnesses the animal may have or develop and from any claim, cause of action or liability for any injury or damage to persons or property which may be caused by the animal. Further, to indemnify and hold P.A.W.S harmless against all claims, including, by not limited to those asserted by third persons, for any injury or damage to persons or property caused by the animal. _____
5. Adopter fully and completely releases P.A.W.S, its agents, servants and employees from any claim, cause of action or liability for any illness adopter's other animals may develop, even if said illness may have been procured from the animal adopted from P.A.W.S. _____
6. This agreement shall be governed by the laws of the state of Texas, and adopter agrees to participate in mediation prior to bringing any action against the P.A.W.S. _____
7. In the event that any term, provision, or paragraph of this agreement is, or is declared illegal, void and unenforceable, this shall not affect or impair the other terms, provisions, or paragraphs of this agreement. _____
8. I understand that a newly-adopted pet may take a month or more to adjust to a new environment and I do intend to commit my time and efforts to help the animal through the adjustment period. P.A.W.S. volunteers are here to answer any questions to help you and your new pet through this adjustment period. _____
9. If for any reason during the lifetime of the animal I am not able to care for it, I agree to return it to P.A.W.S. If the animal is returned after a ninety day period, there will be a \$25.00 return fee for cats or a \$35.00 return fee for dogs. _____
10. I understand and agree that P.A.W.S. does not refund any adoption fees or donations. _____
